#### **BIOGRAPHY**

Mr. Garza was a Founding Partner of CCRG and is presently Of Counsel to CCRG. He specializes in patent and commercial litigation. Mr. Garza is a registered patent attorney who has served as lead counsel in patent-litigation matters in Texas, Delaware, Michigan, and California. He has managed jurisdictional, venue, and Markman disputes, helped secure a jury verdict in the Eastern District of Texas, and prevailed on an appeal at the Federal Circuit. Mr. Garza provides efficient, cost-effective defenses for companies facing meritless patent-infringement claims.

Mr. Garza has represented businesses asserting and defending against claims involving fraud, breach of fiduciary duty, securities statutes, and breach of contract. After founding the firm, Mr. Garza completed two commercial-arbitration proceedings where his clients asserted breach-of-contract and fiduciary-duty claims. Mr. Garza was also recently appointed to try a *pro bono*, excessive-force civil-rights case in the Northern District of Texas.
